VACANT SITE REGISTER - AI052529

Question: Councillor D. Mulligan

"To ask the Chief Executive to give an update on dwellings in the last 12 months registered to the vacant site register and subsequently the number of which have been reinstated for appropriate housing?"

Reply:

Under the Urban Regeneration and Housing Act 2015, each local authority must compile a register of lands in its area that are suitable for housing but are not coming forward for development. On January 1st 2017, these registers were established and an associated vacant site levy will be charged, where appropriate, from January 2019 onwards.

The Urban Regeneration and Housing Act defines a vacant site as any land where:

• In the case of residential land (exceeding 0.05 hectares), there is a need for housing in the area, the site is suitable for housing and the majority of the site has not been in use (i.e. vacant) for an extended period of time

And

• In the case of regeneration land (other than residential land), the majority of the site has not been in use (i.e. vacant) for an extended period of time and where the fact that the site being vacant is having a negative impact on existing amenities or on the character of the area.

The aim of the Vacant Site Register (VSR) is to ensure that key sites are brought forward for larger scale housing and regeneration development. FCC have added sites to the VSR in order to ensure that regeneration or housing zoned lands does not lie unused. It is noted that 2 of the sites (VS 0118 & VS 0124) on the VSR have/had 1-2 dwellings on them. These dwellings were uninhabited at the time of entry on the VSR.

In the last 12 months, 4 sites have been added to the Vacant Site Register. One site, VS 0015 relating to lands in Kilmartin, Tyrellstown has been removed from the Vacant Site Register in the last 12 months as works relating to construction of a housing estate have commenced on this site.
